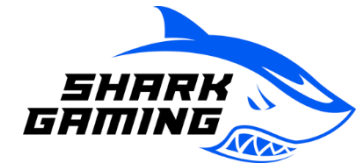

1. Left button
2. Right button

5. DPI down
6. Mouse button 4 (Forward key)
7. Mouse button 5 (Back key)

RGB Controls

1. Forward key (6) + wheel adjustment (3) to change RGB mode.
2. Back key (7) + wheel adjustment (3) to change RGB parameters
